#### 13. PROCEDURE FOR SUBMITTING TENDERS

Financial bids of only those bidders would be opened who fulfill the qualification criteria and are declared qualified in Technical Bid evaluation process by a duly constituted Committee of TEC.

(a) Technical Bid duly signed and EMD should be put in one separate cover and wax sealed (Cover-A). This cover should be super-scribed as:

(b)Financial Bid should be put in another separate cover and wax sealed (cover-B). This cover should be super-scribed as:

Both the envelopes containing the Technical Bids and the Financial Bids should be put in the third envelope (cover-C) duly sealed super-scribed as:

14. The tender should be reached latest by 1500 Hrs on or before 28 Aug 2015. Tender will be opened at 1530 Hrs on 28 Aug by the duly authorized Officer /Board of officers in the presence of all such bidders who wish to be present. Late/delayed offers shall not be opened/entertained under any circumstances. Offers received by due time and date will be opened, (For the Technical Bids only) in Conference Room 4<sup>th</sup> Floor Paryavaran Bhawan at

1530 Hrs on 28 Aug 2015 itself. Authorized representatives of the quoting agency may be present for the opening of the Technical Bids, if they so desire. Successful Agency/Bidders awarded the Rate Contract will have to submit a Performance Security,10% of the contract value after the work assigned to them through Demand Draft or in the form of a Bank Guarantee from any Nationalized Indian Bank within 15 days of the award of the contract. The validity of which would be 60 days beyond the date of completion of contractual obligation of the firm.

#### 15. **Penalty clause** – In case of backing out from the tendering, the EMD may be forfeited

- (i) In case of delay/untimely submission work/assignments, a delay of 0.5% of the contract value per day subject to maximum of 10% of the contract value will be charged as Liquidated Damages on the agency as per provision of LD/penalty clause 8.14 of DGS&D manual policy and procedure for purchase of goods.
- (ii) After issue of the contract, the Performance Guarantee is liable to be forfeited in case of under performance by the agency, besides other action, including black listing of the agency as may be, deemed fit by the Ministry.

#### TERMS AND CONDITIONS

- 1. The Rate Contracts shall be valid for the period of one year from the date of awarding the Contracts. The Annual Rate Contract awarded as a result of this tender enquiry will be in the nature of a standing offer.
- 2. "Corrupt and Fraudulent Practices The Ministry will suspend assignment of works, if it determines that the agency recommend for empanelment as engaged in corrupt (like-offering, giving, receiving or soliciting of anything of value to influence the action of the public officials) and fraudulent practices (like misrepresentation of facts in order to influence empanelment process of execution of a contract to the detriment of Ministry and includes collusive practice among authorized service provider) and initiate process for disempanelment."
- 3. For judicial adjudication, the disputes, if any, arising out of the Contract/Service orders against the Rate Contract will be subject to the jurisdiction of the Courts in Delhi only.
- 4. Translation work to be assigned could be of any nature viz. technical/non-technical material, report, speech etc.
- 5. EMD will be returned to the unsuccessful bidders immediately after award of the Rate Contract to successful agency/bidders. Successful Agency/Bidders awarded the Rate Contract will have to submit a Performance Security,10% of the contract value after the work assigned to them through Demand Draft or in the form of a Bank Guarantee from any Nationalized Indian Bank within 15 days of the award of the contract.
- 6. The payment to the firm/agency will be made on completion of the particular work assigned to them, with the satisfaction of the Ministry after submission of bills in triplicate.
- 7. The agency shall arrange all kinds of resources/instruments/apparatus etc. required for the translation work. This office will not provide any of its resources/instruments/apparatus etc.
- 8. The firm/agency could be removed from the empanelled list, if the quality of translation work is not found up to the mark or incomplete translation work is provided. In the event of any disputes arising out of the execution of Rate Contracts orders, the matter will be referred to Head of the Department. Appeal against the decision of the HOD will lie to the Joint Secretary (Administration), Ministry of Drinking Water & Sanitation.
- 9. Translation charges (inclusive translation, vetting, typing, and proof reading charges should be quoted in the tender. No other payment, whatsoever will be made for any activity/connected with the work other than the agreed translation charges.
- 10. This Ministry reserves the right to amend/withdraw/relax/modify any of the terms and conditions contained in the tender documents or reject any or all applications (offers) without giving any notice or assigning any reason thereof. The decision of the Ministry will be final and binding.

- 11. This Ministry reserves the right to reject any tender/all tenders in full or part thereof without assigning any reasons.
- 12. The tenderers **should sign at each page of the tender and all its Annexures.** No page should be removed /detached from the tender document.
