Sub: Training Programme on Quality Management Systems and Internal Audit of Water Quality Testing Laboratories as per NABL Standards (ISO17025:2005)

Dear Sir / Madam,

In order to streamline water quality testing in laboratories, bring credibility for testing procedures and improve accuracy of results, it is proposed to provide an intensive 4-day training programme on Quality Management Systems and Internal Audit of Water Quality Testing Laboratories as per NABL Standards (ISO17025:2005). This programme is being organized through NABL (National Accreditation Board for Testing and Calibration Laboratories) in CIPET (Central Institute of Plastics Engineering and Technology) campuses at Bhopal, Chennai, Lucknow and Bhubaneswar. It is suggested to take up State level water quality testing laboratory for accreditation, preferably. Alternatively, one or two district level water quality testing laboratories can be taken up in the first phase for NABL accreditation. For this purpose, not more than four participants preferably manpower working in water quality testing laboratories be deputed to the following places as listed below location-wise:

Training at CIPET, Bhopal (13-16 May 2015)

Jammu & Kashmir, Himachal Pradesh, Rajasthan, Gujarat, Madhya Pradesh, Chhattisgarh, Dadra & Nagar Haveli and Daman & Diu

Training at CIPET, Chennai (26-29 May 2015)

Goa, Maharashtra, Telangana, Andhra Pradesh, Tamil Nadu, Puducherry, Karnataka, Kerala, Lakshadweep and Andaman & Nicobar Islandas

Training at CIPET, Lucknow (3-6 June 2015)

Uttarakhand, Uttar Pradesh, Bihar, Jharkhand, Punjab, Haryana and West Bengal

Training at CIPET, Bhubaneswar (24-27 June 2015)

Odisha, Arunachal Pradesh, Assam, Sikkim, Manipur, Meghalaya, Mizoram, Nagaland and Tripura

The Ministry is willing to incur expenditure for this 4-day residential training programmes which includes boarding and lodging, training material, local transportation, etc. The participants nominated by you may be allowed to travel by AIR/Train and expenditure of which may be booked to the NRDWP WQMS funds.
